## 1. Background of the collaboration

### About Erik Smith and Pokerhistory.eu

Erik Smith's father is fighting leukemia and Erik wishes to make a difference by contributing to Kræftens Bekæmpelse (the Danish Cancer Society).

To do so, Erik pledges to donate 2% of all of his Live Poker Winnings as described on Pokerhistory.eu. The total amount will be calculated each year on the 31<sup>st</sup> of December, the first time being December 31<sup>st</sup> 2012, and is sent by email to Anette Juul Paustian on [REDACTED]

The amount is immediately deposited on Kræftens Bekæmpelse's account with Danske Bank:

Before January 15<sup>th</sup> a summary of the collective income from Live Poker Winnings for the past year is forwarded, alongside a note of how much 2% of this number amounts to. If there is any cause for questions, Erik will forward additional information for further analysis of the calculations.

Furthermore, Erik wishes to contribute DKK 1 to Kræftens Bekæmpelse for each "like" of the Facebook group "Pokerhistory.eu" - with a maximum of 20,000 kr. - as well as DKK 5,000 to kick off this donation. The date final for this is April 30, 2012. Erik Smith will send a summary email after the said date to Anette Juul Paustian on [REDACTED]

Erik Smith can mention his support to Kræftens Bekæmpelse on both Pokerhistory.eu and Facebook in this way: Pokorhistory.eu supports Kræftens Bekæmpelse, however, without using the logo of Kræftens Bekæmpelse.

### Duration

This agreement is valid from November 1<sup>st</sup> 2011 to October 31<sup>st</sup> 2014.

### Cancellation

In the case this agreement breaches conditions to the extent that this collaboration conflicts with the ethical guidelines of Kræftens Bekæmpelse, or in any other way mean that the collaboration collides with the general work of Kræftens Bekæmpelse, the agreement can be cancelled immediately by Kræftens Bekæmpelse.

With regards to defaults or breach of terms and conditions, regular Danish law and guidelines will apply. In the case of unforeseen situations that can have a negative effect on the collaboration's partners' respective reputation, the agreement can be cancelled immediately by either partner.

Each partner is responsible for their own expenses for the duration of the agreement, including expenses for the production of marketing materials as described in the agreement.


